- While reporting to this office all the above enlisted candidates are advised to submit following certificates/ Contract form in original and one set attested copies of testimonials:

 - Technical Trade Certificate Mark sheet
 - Case Certificate in case of reserved candidates in the prescribed proforma enclosed in the Notification.
 - Sports and any other Certificates.
 - Contract form in Four copies in original (Proforma enclosed).
 - Offer of Engagement Form in duplicate (Proforma enclosed).
- Above enlisted candidates may download the Offer form and Contract form from the relevant link of the website and complete the required formalities.
- It is also advised to bring original copies of AADHAR CARD, PAN CARD and BANK ACCOUNT number (preferably Nationalized Bank) and submit photocopies of the same. Without Aadhar card, PAN card and Bank Account number further process will not be done.

4. Candidates who are not found eligible in document verification and not fit in medical test but their names appearing in the above list due to typographical error may ignore this offer and do not turn up for further process.
5. If it is noticed that candidates furnished wrong information/fake certificates, the Railway Administration reserves the right to discharge/terminate the selected candidates at any stage without giving notice even after his selection to undergo training.
6. The above candidates may report to this office with required documents as above on 07.01.2019 so that they can be sent for Training commencing from 07.01.2019 to 11.01.2019. After 11.01.2019 not entertained for training.
7. Candidates may carefully note that No TA/DA will be allowed for reporting.
8. Candidates may note that there is No Lodging/Boarding/Messing arrangement from Railway administration will be made for the trainees. Candidates may arrange their own Lodging/Boarding /Messing during the apprenticeship period.
